





This localization covers the functionality and regulatory requirements for general ledger, fixed assets, inventory management, bank management, accounts receivable, accounts payable, and project management.

Venezuela Localization is an extension of the standard functionality of Dynamics 365 Business Central that enables compliance with specific laws and regulations not covered by the out-of-the-box solution.

The various functionalities, printed reports, and physical or digital invoices can be used by both international and local companies operating in Venezuela, in either the private or public sector.

- Accounting and tax requirements mandated by SENIAT (National Integrated Customs and Tax Administration Service of Venezuela).
